

## Governance



Constructive links between the public sector, civil society and the private sector promote effective governance principles and improve the protection of human rights throughout the developing world.

central agencies' economic and resource management at national levels and worked with provincial and local levels to improve public sector effectiveness and efficiency.

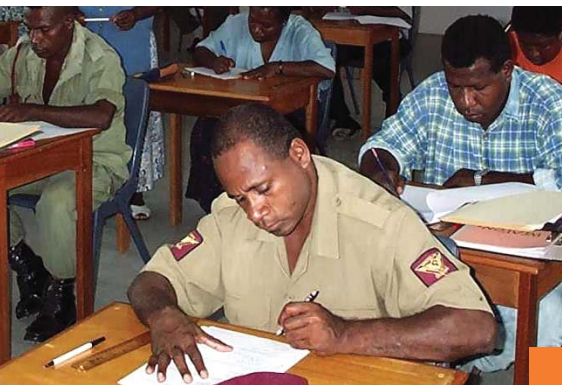
Civil society participation is critical to good governance and Cardno offers experience in a complementary range of support mechanisms relating to decentralisation and strengthening of local governance. Our work focuses on collaboratively developing consultative mechanisms that involve local government and civil society in decision making, with the aim of increasing responsiveness at all levels of government. This strategy builds capacity and performance of governments and NGOs.

To progress good governance, Cardno programs include:

- ▶ Supporting the development of legal and administrative frameworks that promote good governance
- ▶ Strengthening the capacity of senior officials within Ministries to become more effective and accountable
- ▶ Strengthening policies, systems and procedures that improve equitable resource allocation and improved planning and budgeting

- ▶ Implementing reforms across the public and private sectors that support the rights of the community to safety, justice and a viable income
- ▶ Enhancing the skills and capacities of senior officials and their provincial colleagues in advanced data collection and analysis to support the design of frameworks with embedded evaluation methodologies
- ▶ Examining techniques for identifying key stakeholders and for implementing wider and more inclusive consultation processes as part of information collection techniques for policy development and program implementation.
