

## Reconstruction and Rehabilitation



Complex emergencies resulting from conflict or natural disasters cause widespread damage and suffering and often massive population displacement. They are dynamic, hard to predict and pose difficult questions over the timing, nature and scale of donor response.

Post-emergency reconstruction typically involves the repair and reconstruction of physical infrastructure plus interventions aimed at jump-starting the economy and rebuilding and maintaining key social infrastructure. It involves building confidence, self respect, self dependency, mutual trust and the development of a coordinated approach towards sustainability. The vulnerable and marginalised sectors of the community are often the primary stakeholders and partners in the empowerment process.

Cardno provides support that is community owned and monitored, socially and culturally acceptable, facilitates skill development and makes use of materials produced by village industries and rural artisans.
